A part of the West Half of the Southeast Quarter of Section 32, Township 24 North, Range 3 West, Tippecanoe County, Indiana and part of Parcelization No. P89-53, recorded as Instrument No. 89-15804 in the Office of the Recorder of Tippecanoe County and that part of the grantors' land lying within the right of way lines depicted on the attached Right of Way Parcel Plat marked Exhibit "B", described as follows: Commencing at the Northwest corner of the Southwest Quarter of said Section, designated as point "221" on said plat; thence North 89 degrees 32 minutes 16 seconds East 1,320.59 feet along the north line of said southwest quarter section to the northwest corner of the east half of said southwest quarter section; thence continuing North 89 degrees 32 minutes 16 seconds East 1,747.10 feet (1,746.9 feet per said Parcelization) along the north lines of said southwest quarter section and said southeast quarter section to the prolonged west line of Tract II of said Parcelization; thence South 0 degrees 56 minutes 19 seconds East 40.00 feet along said prolonged west line to the north line of said Tract II and the point of beginning of this description: thence North 89 degrees 32 minutes 16 seconds East 200.00 feet along the north line of said Tract to the northeast corner of said Tract; thence South 0 degrees 56 minutes 19 seconds East 125.71 feet along the east line of said tract; thence Southwesterly 246.06 feet along an arc to the right having a radius of 4,100.31 feet and subtended by a long chord having a bearing of South 53 degrees 26 minutes 33 seconds West and a length of 246.02 feet to the west line of said Tract; thence North 0 degrees 56 minutes 19 seconds West 270.66 feet along said west line to the point of beginning and containing 0.917 acres, more or less.

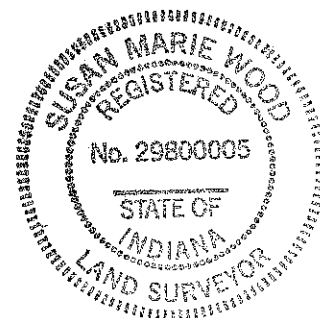
However, the State reserves the right to control access along the line described as follows: Commencing at the south end of the 270.66-foot course described above; thence South 0 degrees 56 minutes 19 seconds East 18.06 feet to the point of beginning of this description: thence Northeasterly 245.60 feet along an arc to the left and having a radius of 4,115.31 feet and subtended by a long chord having a bearing of North 53 degrees 35 minutes 32 seconds East and a length of 245.56 feet and terminating on the east line of said Tract II. This restriction shall be a covenant running with the land and shall be binding on all successors in title to the said abutting lands.

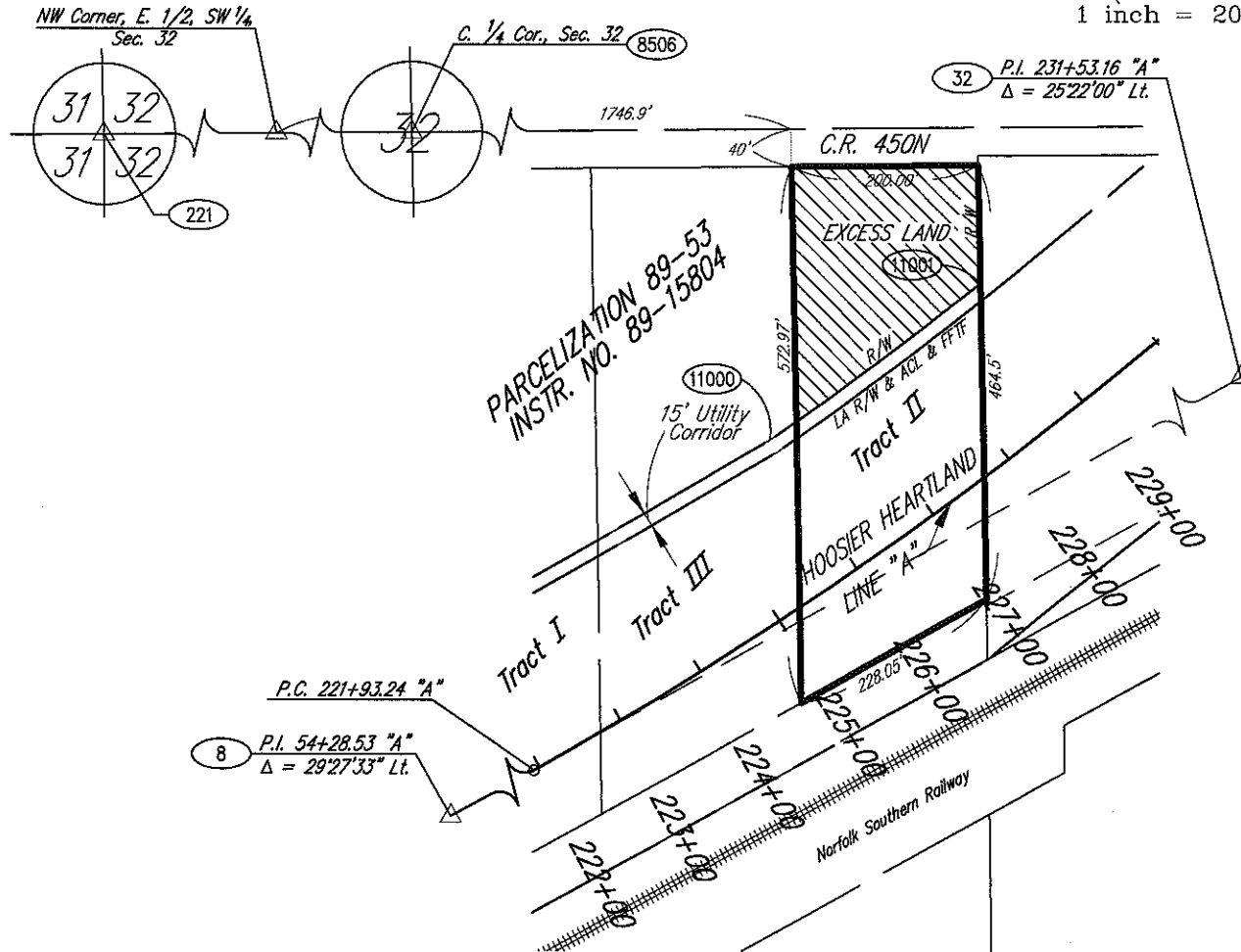
